Notification

Perused the Order passed by Hon'ble High Court in the PIL Case No 47/2021 regarding holding of Compartmental Examination by SEBA as had been done in the past, only in respect of the failed students as per the policy of the Board of Secondary Education, Assam. In the Order the Hon'ble High Court given a liberty to students to approach SEBA for holding Compartmental Examination in respect of the subjects in which they have failed in the special assessment.

As per the policy of SEBA, Compartmental Examination of HSLC/AHM Examination was held in the past, for those candidates who could not come out successful in HSLC/AHM Examination but failed maximum in 3(three) subjects and obtained minimum 170 marks in aggregate. They were eligible to appear in the Compartmental Examination only once as a single chance. The candidate appearing in Compartmental Examination has to secure 30% and above marks in the subjects appeared and his total marks must be 180 to come out successful.

Hon'ble High Court in the order mentioned above that SEBA has to decide sympathetically for holding the Compartmental Examination. Therefore, keeping in view of the Order of the Hon'ble High Court, the Board of Secondary Education, Assam is contemplating to start the process of conducting the Compartmental Examination as per the aforesaid order after declaration of the result of the Special Examination to be held from 1st Oct.,2021 to 11th Oct.,2021 on a suitable date on receipt of proper applications from the willing students who failed in maximum three subjects and secured minimum 170 marks in aggregate, in the result published of HSLC/AHM examination 2021 through the Head of the Institute. The Head of institutions will have to submit the applications along with the list of willing candidates to the Inspector of Schools of the District.

The facility of Compartmental Examination so conducted will also be extended to the candidates of the Special Examination which will be held from 1st October, with the same principle if they are unsuccessful and failed to pass the said examination but meets the eligibility criteria to appear the Compartmental Examination as stated earlier.

Accordingly, as per instruction of the Hon'ble High Court, all the Inspector of schools are directed to receive applications from the students who are qualified to appear in Compartmental Examination as per procedure of SEBA.

There be will two categories of applicants, one who have already applied to appear in the Special Examination and the other, who have not applied for the Special Examination.

The candidates who have received Admit cards for the Special Examination and applied for the Compartmental Examination, are allowed to appear only in subjects, in which they

came out unsuccessful,subject to a limit of three subjects and secured minimum 170 marks. All other students who have received Admit Card of Special Examination including those who have failed in four or more subjects will have to appear in all the six subjects. The Center in Charge of the Examination centers of Special Examination are hereby authorized to take action,accordingly.

For the candidates, who have not applied for Special Examination and otherwise eligible for the Compartmental Examination, SEBA will conduct Compartmental Examination, as per suitability, in due course. The process will start after declaration of results of Special Examination. The willing candidates,who are qualified and desires to appear in the Compartmental Examination, has to submit their application as and when process is started. This facility shall also be extended to the candidates, who appeared in all the six papers of Special Examination, and came out unsuccessful.
